An Appeal Case U/S 19(3) of RTI Act, 2005.
Vide Case No. APIC-138/2024

(Or. 5, R.3 of CPC)

Shri Sunday Bagang –VS- PIO-cum Chief Engineer (RWD), Govt, of Arunachal Pradesh, Itanagar.

ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Sunday Bagang on **14.12.2024** filed an RTI application under Form-‘A’ before the PIO-Cum- Chief Engineer (RWD), Govt. of Arunachal Pradesh, Itanagar whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **16.02.2024** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **27.02.,2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 138/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on **16th May 2024** & **22nd August 2024**. In this hearing of the appeal on **22nd August ,2024**. Both the parties found absent during the hearing without intimating the reason for his inability to attend the hearing.

However, the Appellant has submitted a letter to the Commission through wats app that he has received all the information as sought in his Form ‘A’ application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
