JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Lokam Namdu on **16.05.2023** filed an RTI application under Form-'A' before the PIO-Cum-Block Development Officer, CD Block, Damin & Paniasang, Kurung Kumey District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **19.06.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.08.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 758/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) time i.e on **09/10/2023, 29/11/2023, 22/01/2024, 03/04/2024 and 12/06/2024**. In this hearing of the appeal on 12th day of June, 2024, appellant present during the hearing and PIO found absent. During the hearing the appellant has stated before the Commission all the information as sought by him has already been provided by the PIO and he is satisfied with the information and he requested the Commission to dispose off his appeal case No. APIC-758/2023 filed against the PIO-cum-BDO, Damin & Paniasang.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
