Judgement / Order

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Ram Kasang on 27.12.2021 filed an RTI application in Form-A to the PIO cum DFO Shergaon (Rupa) O/o the Divisional Forest Office Shergaon Forest Division Rupa West Kameng District Govt. of AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal on 09.02.2022 before the First Appellate Authority, the Chief Conservator of Forest, Western Circle Banderdewa Papumpare District AP.

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 26.05.2022.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.357/2022 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 10th hearing before the Commission Court today on 05.09.2024.

In this hearing of the appeal on 05.09.2024 the respondent PIO cum DFO Shergaon (Rupa) O/o the Divisional Forest Office Shergaon Forest Division Rupa West Kameng District is absent. However, the PIO is represented by Shri Sagar Tasing (APIO). The appellant Shri Ram Kasang appeared.

Heard the parties present.

The appellant submits that the information has been received except following items:

1. Partial official bank account detail of DFO Shergaon & complete official bank account statement of RFOs.
2. Copy of advertisement in two local daily newspapers.

The PIO's representative states that complete official bank account statement of DFO Shergaon has been furnished to the appellant. Newspaper cutting is not available in PIO's office as they did not publish advertisement in any newspaper.

Having received all other information earlier and upon hearing the statement of the representative of the PIO in the commission court today, the appellant has requested the Commission to dispose of and close this appeal case.

In view of the above facts and circumstances I find this appeal is fit to be disposed of and closed. Accordingly, this appeal stands disposed of and closed once for all.
