JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Tagi Ruti on **01/08/2023** filed an RTI application in Form- 'A' before the PIO-cum-EE, RWD, Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **05/10/2023**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **15/11/2023** and the Registry of the Commission (APIC) having receipt of the complaint registered it as **APIC No- 1057/2023 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission, on **28/11/2024**. In the first hearing of the appeal the Appellant Shri Tagi Ruti though not present, submitted a letter for disposal of this appeal on ground of satisfactorily receipt of all the information(s) sought from the PIO. The PIO is not present during the hearing.

In view of the above facts and circumstances, the Commission considering the letter for disposal of this appeal as submitted by the Appellant, finds this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed and closed once for all.
