ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Shoney Pertin for non-furnishing of below mentioned information by thePIO, o/o the Executive Engineer, Pasighat Smart City Development Corporation Limited (PSCDCL) Dist : East Siang, Pasighat (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 30.07.2024

A. Particular of information: Construction of Recreation center (Indoor game set)

B Details of information:

- 1.Certified copy of DPR and sanction order;
 - 2.Certified copy of agreement.
 - 3.Certified copy of designing and drawing.
 - 4.Certified copy of payment details of PFMS to till date.
 - 5.Names of the officer who inspected the work site.
- C. Period for which information asked for : 2022 to till date.

This Commission on 07.02.25, upon hearing the parties, passed the following interim order:

"Heard the parties.

The Appellant submitted that he had so far received information about the names of Officers who inspected the work site as requested by him vide S.No.(5) of his RTI application dated 30.07.24.

He therefore, reiterated his demand for the information/documents sought for vide Sl. No. (1) to (4).

This Commission, upon hearing the parties, directs the PIO to furnish the information, whichever is disclosable under the RTI Act, and also furnish cogent reasons against those not disclosable/exempted under the RTI Act on or before 19.03.25, the date of next hearing."

The appeal was, accordingly, heard on 19.03.25 wherein the Appellant, Shri Shoney Pertin and Adv. T. Marngar, Learned Counsel for the PIO, o/o the E.E Pasighat Smart City Development Corporation Ltd., Pasighat East Siang District (A.P) are present in person.

Heard the parties.

The appellant reiterated his demand for the information as requested vide his application while the Counsel for the PIO submitted that except for the copy of the DPR and the Drawing & design, the other left out document i.e the certified copies of payment details of PFMS will be provided to the appellant.

This Commission, upon hearing the parties and considering the fact that similar documents such as the copies of DPR, Agreement and Drawing and Designs were requested by the appellant in respect of other projects also and in respect whereof this Commission had passed interim order (in appeal case No/APIC-360/2023) directing the PIO to furnish those documents, hereby directs the PIO to provide the left out documents relating to the project in question i.e c/o Recreation Centre also and report compliance thereof within 4(four) weeks.
