- v. Furnish the copies tender floated participated documents for awarding the work against M/s H.M Enterprise.
- vi. Furnish the copies of total list and name of the firm and contractor who are executing the ongoing C/o SPT Project at Chimpu Itanagar.

Period for which information asks for: Since inceptions to till date.
