**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Charu Tatung on **30.01.2024** filed an RTI application under Form-'A' before the PIO-Cum- Director of Land Management Department, Itanagar, P/Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **04.03.2024** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.04.2024** and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 173/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 04.06.2024. In this hearing of the appeal on 4<sup>th</sup> day of June, 2024. The Appellant Shri Charu Tatung and the Dy. Director- cum-APIO Shri Taken Doke present during the hearing. Heard both the parties.

The APIO stated before the Commission that the information sought by the Appellant in his Form A application *serial no. 1, 2, 4 & 5* are not available with the O/o the Directorate Land Management Department but, may be available with the O/o the Deputy Commissioner, ICR and the serial no. 3 is already furnished to the Appellant.

The Commissioner after hearing the APIO and going through the application of the applicant, directed the Appellant to file a fresh application to the concerned Competent authority or Department where he can get the remaining information sought by him. Hence, this appeal is disposed off /closed.

The Appellant agreed and satisfied with the direction and judgment passed by the Commission and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of information sought from the PIO.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
