## ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Ngwazosa Yopin on <u>14.02.2024</u> filed an RTI application under Form-'A' before the PIO-Cum-Director, Namdapha National Park Miao, Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on <u>02.04.2024</u> the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information on <u>03.05.2024</u> and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 197/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three times i.e on 13/06/2024, 08/08/2024 & 19.09.2024. In this hearing of the appeal on 19<sup>th</sup> day of September, 2024. Both the parties, the Appellant and the PIO heard through online mode.

Heard both the parties.

The PIO stated that as per the last order passed by this Commission on dated 08.08.2024 left out information(s) for serial no. 2, 3 & 6 has been furnished to the Appellant mentioning that his office does not have any records as his office is not responsible for the land settlement proceedings. And also stated that the above mentioned information(s) might be with Deputy Commissioner, Changlang.

After hearing the PIO, the Commission explained and ordered:

- (i) The Appellant, as per the provisions of RTI Act, 2005 all the information(s) which sought by him had been furnished to him by the PIO. So, this Court does not have any meaning to fix or take further hearing of this appeal.
- (ii) Therefore, if the Appellant needs he is given liberty to file a fresh application to the concern Competent Authority-cum-DC, Changlang, for the information(s) which are not available with the PIO in the instant appeal.

After hearing the Commission, the Appellant understood the matter and has requested the Commission for disposal/closure of his appeal on ground of understanding the facts of the matter.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed.

And, accordingly, this appeal stands disposed and closed once for all.
