**Information sought:**

The appellant filed an RTI application dated 09.11.2023 seeking following information regarding appointment order in respect of Shri Tadung Rigia (Dokum) OSD of Board etc from 2019 to 2024.

Details of Information required:

1. Produce a copy of first appointment order in respect of Shri Tadung Rigia (Dokum), OSD of the Board.
2. Produce a copy of Government Notification for Appointment of OSD in the Board.
3. Produce a copy of supply order along with the bills whom to awarded the supply work by the board of the following items- Mask, Sanitizer, Tiffin, Bags,

Filter etc. for the year 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24 in separate sheets.

4. Produce a copy of Distribution List of Welfare Kids to all RO's of the entire district of Arunachal Pradesh in the year 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24 in separate sheets.
5. Produce a copy of sanction order against the allocation of fund to all districts RO's of Arunachal Pradesh in the year 2021-22, 2022-23 & 2023-24.
6. Produce total Input GST payment made to be paid by supplier against the procurement of welfare kids by the board from the year 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24 in separate sheets.

The following were present.

**Appellant** : Present. He states that the PIO has furnished all the sought information to him. He is satisfied with the information (serial no. 2 to 6 in RTI application) furnished by the PIO except serial no.1.

Pertaining to information to serial no.1, the information furnished for approval order of Shri Tadung Rigia (OSD) is dated 10.08.2023. Whereas Shri Tadung Rigia has signed as OSD, APB&OCWWB in the appointment of contractual driver and peon dated 11.10.2021 and 21.02.2022 respectively (copy of order produced by the appellant). The appellant is seeking the appointment order of Shri Tadung Rigia as OSD, APB&OCWWB prior to 11.10.2021.

**Respondent PIO** : Present. He has agreed to furnish the information at serial no.1, the appointment order of Shri Tadung Rigia as OSD prior to 11.10.2021, if available in the office and requested for 15 days time.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, perusal of the records and hearing, observes that the appellant is not satisfied with the information furnished for serial no. 1 in the RTI application in form-A.

The PIO is directed to furnish a copy of appointment of Shri Tadung Rigia as OSD to the Chairman, APB&OCWWB prior to 11.10.2021 to the appellant within two weeks from the date of issue of this order i.e on or before 03.04.2025 under intimation to this commission court. The appellant shall file written submission to this commission court the status on receipt of information from the PIO.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO.
