JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Miss Bengia Mamu on 07.09.2024 filed an RTI application under Form-'A' before the PIO-cum-Assistant Director, Textile & Handicraft, Pasighat, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 01.11.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information on 01.12.2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 419/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 26/05/2025. In this hearing of the appeal on 26th day of May, 2025, both the parties, PIO-cum-Asstt. Director, Textile & Handicraft, Pasighat and Miss Bengia Mama found absent, however, the appellant Miss Bengia Mama has submitted a letter addressed to the Hon'ble State Information Commissioner requesting to dispose off the appeal case No. APIC-419/2024 and stating that she has received all the information as sought by her and she is satisfied with the information provided.

Request accepted and dispose off the appeal case No. APIC-419/2025.
