ORDER

1). This was an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Lajamang Mannow, Nanam Khamti Village, PO-Manmow, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(E), Govt. of Arunachal Pradesh, O/o Executive Engineer (E), Namsai Electrical Division, Department of Power, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/06/2024 regarding appointment of W/C staffs.

2). The 1st hearing was held on 18th February, 2025. The PIO-cum-EE(E), Govt. of Arunachal Pradesh, O/o Executive Engineer (E), Namsai Electrical Division, Department of Power, Namsai District, Arunachal Pradesh was represented by Er. Chow Kolata Manjekhun, AE (E), Namsai Electrical Sub-Division. The Appellant Chow Lajamang Mannow was present.

3). The Commission on scrutiny of the information furnished by the PIO, had observed that only the information sought at **Sl.no. (d) i.e., detail of Board Members** was not furnished. The Commission had directed the PIO to furnish the particular information to the Appellant within 15 (fifteen) days from the date of issue of the hearing order. The Appellant was asked to visit the office of the PIO, collect information and intimate the status to the Commission.

4). The Appellant vide letter No. NIL Dated 15/03/2025 informed the Commission that the PIO furnished the information and he is satisfied. The Appellant appealed to dispose of the case. The Commission on appeal of the Appellant decides to dispose of the case.

5). **Therefore, the case is hereby closed and disposed of.**
