JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Mamu Sono on 17.9.201 filed an RTI application in Form-A to the PIO-cum-PD DRDA Seppa, East Kameng District, Govt. of Arunachal Pradesh, whereby, seeking various information as quoted in Form-A application. Appellant being not furnished with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 25.10.2021. Appellant again having not received therequired information from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 29.11.2021 and Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No. 365/2021 and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission for 13th hearing today on 17.5.2024. In this final hearing of the appeal on 17.5.2024 the

PIO-Cum-PD DRDA Seppa, East Kameng District found absent during the hearing and the appellant present during the hearing. The appellant submitted a written application to the commission stating that he has received all the information as sought in his Form-A application and has requested the Commission for disposal / closure of his appeal on the ground of satisfactorily in receipt of all information sought from the PIO. Interim orders passed by the commission during previous hearings have been complied by proving all information to the satisfaction of the appellant.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
