## Facts:

# ORDER

The brief facts of the case, as reveals from the records, are that the appellant, Shri Nabam Tadap, Zoo Park Colony, Itanagar vide his application dt.28.04.23 filed before the Public Information Officer o/o the Executive Engineer, (PHE &WS), Itanagar Division, has sought information on 24 points (Sl. No 1 to 24) regarding shifting of water pipe line at right of way (ROW) from Gohpur Tinali to NIT, Jote (State High Way).

Records disclose that the information as requested by the appellant remained unfurnished despite the appellant's appeal to the 1<sup>st</sup> Appellate Authority vide appeal dt.01.06.23. Hence, this Second appeal before the Commission which was filed on 11.07.2023.

# Hearing and decision:

The appeal was heard for three times on 31.01.24, 10.05 .24 and 05.06.24.

In the first hearing on 31.01.2024, wherein both the appellant and the representative of the PIO were present, the representative of the PIO submitted that the PIO did not receive the application (Form-A) filed by the appellant. The Commission after hearing the parties provided the copy of application to the representative of the PIO and directed the PIO to furnish the sought for information to the appellant on or before the next date of hearing.

In the second hearing on 10.05.2024, the appellant was absent but the APIO, Er. Shri Tad Logi, AE, PHE & WS, Itanagar Division attended the hearing who had brought in the information to be handed over to the appellant. The Commission took delivery of the information for handing over to the appellant and fixed the next date of hearing on 05.06.2024 and in the meanwhile the information was handed over to the appellant

In the 3<sup>rd</sup> hearing of the appeal on 05.06.2024 both the appellant and the representative of the PIO were present who were duly heard. The appellant submitted that he has not received the complete information as yet from the PIO. The representative of the PIO assured the Commission that the complete information would be furnished to the appellant within one week which the appellant was directed to go through and inform his satisfaction / dissatisfaction on or before the next date of hearing. Meanwhile, the appellant, vide his application dt.14.06.2024 addressed to the Commission, informed that he has received the complete information he had sought for from the PIO and that he is fully satisfied with the same and hence he requested the Commission to dispose of the appeal accordingly.

Under the premises as above the Commission finds that the appeal requires no further adjudication and therefore, fit to be closed as such.

The appeal, accordingly, stands closed.

Order may be issue accordingly.
