**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Luknyak Kena on 30.01.2023 filed an RTI application under Form-'A' before the PIO-Cum-Block Development Officer, CD Block, Maro & Baririjo, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 31.08.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.10.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 998/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) time i.e on 13/11/2023, 11/12/2023, 29/01/2024, 29/04/2024 and 17/06/2024. In this hearing of the appeal on 17<sup>th</sup> day of June, 2024, PIO present during the hearing and appellant found absent without any information to the Commission.

During the hearing, the PIO has intimated to the Commission that he has brought all the information/documents to hand over to the appellant, but due to absence of the appellant documents could not be handed over. It is seen that the appellant is absent for the last **3(three) consecutive hearing dated 29/01/2024, 29/04/2024 and 17/06/2024, despite of giving information through official correspondence & through whatsapp message.** It seems that the appellant is not interested to pursue the case further.

In view of the above facts and circumstances, I find this appeal fit to be disposed off in the absence of the appellant. And, accordingly, this appeal stands disposed off and closed once for all.
