**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Dawa Tsering on **16/11/2023** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (PHE) Dirang Division. District West Kameng Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not in receipt information from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **03/01/2024** the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **30/01/2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 189/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for five times i.e on **18/06/2024, 30/07/2024, 03/09/2024, 26/11/2025, 04/02/2025 & 08/04/2025**. In this hearing of the appeal on **8<sup>th</sup> day of April'2025**. The Appellant is present during the hearing through online mode but PIO found absent during the hearing.

However, the Appellant has submitted before the Commission, that he has received all the information as sought in his Form 'A' application but requested the Commission that disciplinary action be initiated against the PIO as per provision of RTI Act 2005 for providing the information lately but the Commission outrightly rejected his request. The Appellant stated that he received the information from the PIO but the proper Geo-Tag documents have not been provided to him by the PIO.

Upon the observations of the Commission the Appellant has not applied for providing the information regarding Geo-Tag documents in his form 'A' application and Appellant has self admitted that he has got all the information from the PIO, and hence, this appeal need not be heard furthermore.

In view of the above facts and circumstances of the case the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed.
