Information sought :

The appellant file an RTI Application dated 11/09/2023 seeking Details regarding Renovation and Realignment of 11KV line from Yazali to Taib Village.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Nabam Pekhi present in person

Respondent : PIO-cum-EE (Electrical), Yazali Division present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Pekhi **11.09.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Electrical), Yazali Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **19.11.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 02 (R)/2024 (02/2024)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3(three) times i.e on 10/03/2025, 16/04/2025 and 30/04/2025. In this hearing of the appeal on **30th day of April, 2025**, both the parties the PIO-cum- EE (Electrical) , Yazali Division, Lower Subansiri District and the appellant Shri Nabam Pekhi present in person.

The PIO has stated that he has provided all the information as per the Form 'A' Application sought by the appellant. The appellant has submitted an appeal addressed to the Executive Engineer (Power), Yazali Division regarding his dissatisfaction of the documents provided.

In Sl. No. 1 he has sought clarification regarding cheque issued without proper name which is not liable to answer by the PIO.

Sl. No. 2 the total pole for 11 KV from Yazali to Taib Village is in work order copy provided to the appellant.

At Sl. No. 3 appellant has stated that NIT is not available with executing work order and the appellant wants clarification from the PIO, how the work amounting more than one crore has been executed without NIT. In this also the PIO is not liable to answer the clarification of the appellant.

Going through the case record, the PIO has provided all the information sought by the appellant and the Commission deems fit to dispose off this appeal case.

Accordingly, the appeal case is disposed off and closed. However, the appellant is at liberty to file further appeal before the appropriate authority if feels aggrieved by decision of this Commission.
