



ARUNACHAL PRADESH INFORMATION COMMISSION ITANAGAR.

An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-195/2025.

APPELLANT

: Shri Khya Changrang

RESPONDENT

: (i) The PIO, o/o the E.E (RWD), Anini Division.

(ii) The PIO, o/o the Chief Engineer (RWD), Govt. of A.P Eastern Zone, Itanagar.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Khya Changrang for non-furnishing of below mentioned information by the PIO, o/o the Chief Engineer (RWD), Govt. of Arunachal Pradesh, Eastern Zone, Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 28.08.2024.

A) Particular of information :M/s Zec Engineering & construction, NOCEAP (D&P) /PLG- 48/2008 - 09/1/62 dtd. 16/10/2008.

B) Details of information required:

- 1. Contractor Registration details including renewal status and company profile.
- 2. Year wise list of all project undertaken by the contractor within the department.
- 3. Copies of completion certificate, agreement and LOA Audit reports.
- Financial records including payment details.
- 5. Records of legal or disciplinary action and any complaint reports.
- 6. Period for which information is sought for: 2010 to 2024.

Brief facts:

Records reveal that the appellant had requested the PIO for the above mentioned information but could not obtain the same within the statutory period of one month which prompted him to approach the First Appellate Authority, the Chief Engineer (RWD), (E/Z), Rural works Department, Govt of A.P. Itanagar.

Records further reveal that the FAA conducted the hearing of the appeal on 16.12.2024 and directed the E.Es/PIOs to furnish the information in original to the appellant directly.

It was, however, noticed from the letter dt.07.05.2025 from the Chief Engineer (EZ), RWD, Itanagar addressed to the Registry of this Commission that except the EE, Anini Division, all other Divisions had submitted Nil report.

The EE, Anini's letter dt. 27.10.2024 addressed to the appellant also indicated that the firm, M/s Zee Engineering and Construction executed a road construction namely, BRTF road to Kano during 2019.

It was also noticed that the EE-cum-PIO, RWD, Anini Division in his aforesaid letter had furnished the following replies to the appellant:

- 1. Contractor Registration details: Registration Certificate and revalidation (enclosed);
- 2. Year-wise list of projects undertake, 2010-2024: One project has been undertaken by the firm, M/S Zee Engineering and Construction i.e BRTF road to Kano during 2019;
- 3. Completion Certificate, Agreement and LOA: Ongoing;
- 4. Financial record including payment details and audit report: NA;
- 5. Records of legal or disciplinary action and any complaint report: Nil

The appellant, being aggrieved with the decision of the PIO as above, had preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act vide his Appeal Memo dt.17.02.25.

Hearing & decision:

The appeal was, accordingly, listed and heard on 23rd May, 2025 wherein the Appellant, Shri Khya Changrang was present but the PIO o/o the Chief Engineer, (RWD), Eastern Zone, Dist. Papum Pare, Itanagar was absent.

This Commission upon hearing the appellant and on perusal of the aforementioned letters dt.07.05.2025 from the Chief Engineer (EZ), RWD, Itanagar as well as the letter dt. 27.10.2024 from the EE, Anini Division, directed the E.E, Anini Division to furnish the left out information i.e. point number 3 and 4 to the appellant on or before 09.07.2025 i.e the next date of hearing.

During the course of hearing on 9th July, 2025, both the appellant, Shri Khya Changrang and the PIO, Er. Shri Kardo Rina, E.E. were present in person. As directed by this Commission in order dt. 23.05.2025, the PIO brought in the left out documents and handed over to the appellant who, however, complained that the following documents were still remained to be provided to him and pleaded this Commission for direction to the PIO to provide:

- 1. Targeted date of completion of the project;
- 2. Drawing of the project;
- 3. Bill of quantity and
- 4. Notice of commencement of the project.

The PIO assured to provide the aforesaid remaining documents as soon as possible.

This Commission, upon hearing the parties, directed the PIO to furnish the left out documents to the appellant within 2 (two) weeks from 9th July, 2025 and the appellant was also directed intimate this Commission within 1 (one) week of the receipt of the documents failing which it was made clear that this appeal shall stand closed without further notice presuming that he had received the documents correct and is satisfied therewith

In compliance with the direction of this Commission, the PIO, vide letter dt. 11th July, 2025, addressed to the appellant, furnished the replies to the remaining queries the receipt of which has been acknowledged by the appellant vide letter dt. 22nd July, 2025.

In the premises as above, this appeal is disposed of and closed.
