JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram & Shri Takam Sakap on **18.07.2023** filed an RTI application under Form-'A' before the PIO-Cum-EE, (WRD), Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 954/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 4 (four) times i.e on 18.12.2023 & 19.01.2024, 27.03.2024 & 05.06.2024. In this hearing of the appeal on 5th day of June, 2024, Appellant Shri Riya Taram present but PIO-cum-Executive Engineer (WRD), Likabali Division found absent.**

However, the appellant submitted a letter on dated 03/04/2024 to the Commission that the PIO has furnished all the information as sought by him in his form 'A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information as sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.
