ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tania June for non-furnishing of information by the PIO, o/o the DMO, Siang District, Boleng (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 10.10.2023.

The appellant herein had requested the PIO for the following information:

1. Subject matter of information required: -Regarding appointment of under Field Worker (FW)/ Regular Field Worker (RFW)/ Supervisor field worker (SFW)/ANM/ of entire Siang District.
2. Details of information required: -
 - (a)Furnish appointment order copies
 - (b)Furnish joining report copies
 - (c)Furnish class x pass certificate copies
 - (d)Furnish class xii pass certificate copies.
3. Period from which information asked for: 2017 to till date.

The appeal was listed for hearing for 2 times earlier on 20.11.2024 and on 6th December, 2024. In the hearing fixed on 20.11.2-24 both the appellant and the PIO were absent. On 06.12.2024 also, the appellant was absent but the PIO, o/o the DMO Siang District, Dr. Tarik Talom attended the hearing through the V.C.

During the course of hearing, the PIO submitted that the information sought for by the appellant vide his application dt.10.10.2023 had already been furnished to him vide letter dt.17.11.2023, a copy whereof, was also forwarded to this Commission through WhatsApp.

But since the appellant was absent in the hearing, the receipt of the information (complete or incomplete) by him could not be confirmed. The hearing of this appeal was, therefore, adjourned again to 22.01.2025 with the direction to the appellant to intimate to this Commission of his acknowledgment of the receipt of the information on or before 22.01.2025 or to attend the hearing on that date (22.01.2025) with the warning that if he fails to comply with the direction/order, then it will be presumed that he had received the information and is satisfied therewith and accordingly, this appeal shall be closed as such.

Since the appellant failed to either intimate his acknowledgement of the receipt of the information from the PIO or to attend the hearing, this Commission presumes that he had received the information and is satisfied therewith and consequently, this appeal stands closed.
