Regarding Information to implementation of development works under CAMPA schemes, Non-Plan (Revenue Head) & SADA scheme in Khellong Forest Division Department of Environment & forest, GoAP.

Particulars of Sought information are given below:

### CAMPA SCHEMES:

- 1. Please provide me certified: sanction order copies and detail of LOC copies against all the works sanctioned under CAMPA scheme (As per APO approved) from the year 2018-19, 2019-20, 2020-2021, 2021-2022 & 202223.
- 2. Furnish certified Notice Inviting tender (NIT) copies, along with name of newspapers, date of publication of newspaper where Notice Inviting Tender (NIT) was published for each financial year i.e 2018-2023 against all the sanctioned works under CAMPA scheme (as per APO approved)
- 3. Also provide me details of Tender Evaluations documents against each items of works along with Technical and financial bids of the firms under CAMPA scheme from the year 2018-2023.
- 4. Furnish the name of firms participated in Tender process against each items of works under CAMPA scheme along with name of firm won the tender works from the year 2018-2023.
- 5. Furnish the certified copies of commencement/work order letter issued to the winning firms owner in the Tender process for each items of works under CAMPA scheme from the year 2018-2023.
- 6. Furnish all the photocopies in GLOSSY PAPER for each items of work under CAMPA scheme, photographs required before starting of works and after completion of works including Geo-coordination reports from the year 2018-2023.
- 7. Furnish the payment details made to the firm, cheque numbers vouchers, bill and PFMS reports against each items of works under CAMPA scheme from the year 2018-2023.
- 8. Furnish the certified copy of completion certificate against each items of works under CAMPA scheme from the year 2018-2023.
- 9. Furnish the certified copy of utilization certificate (UC) for each items of works under schemes from the year 2018-2023.
- 10. Furnish the approved DPR copies of each items of word as per approved APO under CAMPA scheme from the year 2018-2023.
- 11. Furnish the name of officers and their designation at the time of monitoring the works under CAMPA scheme from the year 2018-2023.

- 4. If any works carried out by contractors under Non-plan than please furnish details of information of it.
- 5. Utilization Certificate (UC) against the works under Non-Plan from the year 2019-2023.
- 6. Completion certificate against the works under Non-Plan from the year 2019-2023.
- 7. Furnish the entire NIT copies, newspapers and date of publication of newspaper where NIT was published for each items of works under NonPlan from the year 2019-2023.
- 8. Furnish the approved DPR for each items of work under Non-Plan from the year 2019-2023,
- 9. Furnish the colour photograph in GLOSSY paper of each items of work, before starting of work and after completion of work and Geo-tag information of each work site under Non-Plan from the year 2019-2023.
- 10. Furnish the name of officer and their designation at the time of monitoring the works under Non-Plan from the year 2019-2023.

# **SADA SCHEME**

- 1. Sanction order and LOC copies of works sanction under SADA scheme from the year 2018-19, 2019-20, 2020-21, 2022-2023.
- 2. Utilization Certificate (UC) of works sanctioned under SADA scheme from the year 2018-2023.
