ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the State Public Information Officer (SPIO), Govt. of A.P. Department of PWD Capital Circle-cum-Coordination Training & Vigilance, Itanagar as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/03/2023 regarding appointment of under Junior Engineer (JE) Civil, Sports Quota / Handicapped/General of advertisement Date on 26th, 27th, 28th 29th September 2016.

The 8th hearing was held on 5th November 2024 (Tuesday) at 1030 hrs. Both the parties were found absent. During the 7th Hearing held on 1st October 2024 (Tuesday) the PIO while attending the court hearing through online mode informed the Commission that due to some communication gap the collection of information from the district branches was delayed. However, he clarified that all the required information were available in his custody now and that the Appellant could collect the same on any office working day.

The Commission directed the Appellant to collect the information from the office of the PIO and inform the Commission in writing, failing which the case would be closed and disposed of without further notice.

Now, for the 8th hearing, Shri Tania June, the Appellant was absent and no intimation for non-presence in the court had been received. It is observed that the Appellant is not serious to obtain the information as filed in the Form-A.

Therefore, the Commission is of the view to dispose of the case without any further notice.

Hence, the case is disposed of and closed.

Order be issued accordingly.
