- 4. Furnish the NOC copy from concern villagers, Goan Burah, Head Gaon Buras, GPC /SMC.
- 5. All the agreement should be made of court/judicial stamp paper with seal and sign of judicial magistrate.
- 6. Furnish the DPR copies of each school.
- 7. Furnish all the documents made be in true and certified by concern PIO.

#### **Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that FAA has not disposed of the first appeal filed to him.

As laid down at para-38 of the Guidelines for the FAA issued by the GoI and the State Govt. OM No. AR-111/2008 Dated 21<sup>st</sup> August, 2008, adjudication on the appeals under RTI Act is a quasi-judicial function. It is, therefore, necessary that the Appellate Authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be a speaking order giving justification for the decision arrived at.

Therefore, the instant appeal case is remanded to First Appellate Authority. Therefore, the **FAA** — **Deputy Commissioner**, Kurung Kumey District, following the principle of natural justice, shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within three weeks from the date of receipt of this order i.e **on or before 03.04.2025.** 

Liberty is given to the appellant to file 2<sup>nd</sup> appeal afresh if not satisfied with the decision of the FAA / or PIO has not provided satisfactory information after order issued by the FAA. Fee for such 2<sup>nd</sup> appeal, if done, shall be exempted.

The appeal is disposed of accordingly at Commission.
