Respondent PIO Shri Chagam Dolo BDO Hawai CD Block appeared.

Appellant Shri Dongru Tania is absent.

Heard the party present.

Shri Chagam Dolo PIO cum BDO Hawai states that no RTI application dated 09.02.2023 from Shri Dongru Tania is available in his office. He has made written submission to this effect stating that he has joined as BDO Hawai Block in the month of August 2023 and the information sought period pertains to his predecessor and order be passed for furnishing information by his predecessor.

On perusal of records in the case file it is seen that the RTI application in form 'A' was dispatched by postal service but acknowledgement of delivery is not available

in record. The first appeal to the FAA cum DC Anjaw was also dispatched by postal service and acknowledgement of delivery is not available in record. No order of decision or response from the FAA is available.

Show cause was served to the PIO in the hearing order dated 8.12.2023 as to why maximum penalty should not be imposed on him under section 20(1) of the RTI Act 2005.

The show cause served to the PIO is halted for time being. It is directed to the current PIO cum BDO Hawai Block Shri Chagang Dolo to furnish the admissible information under the provision of RTI Act 2005 within period of 30 days on receipt of the RTI application in form 'A'. The appellant Shri Dongru Tania to approach the PIO cum BDO Hawai with copy of this order and a copy of original RTI application in form 'A' without tempering and obtain acknowledgement

The case is adjourned to 10.06.2024 at 02:00 PM.
