The appellant file a RTI Application dated 24/07/2024 seeking Details regarding Implementation of C/o Flood Protection and Street filling work at Upper Deobel under Namsai, Ph-I.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 02/09/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **24.07.2024** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (WRD), Namsai Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **02.09.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16.10.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 286/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 10/03/2025. In this hearing of the appeal on 10th day of March, 2025, both the parties, PIO-cum-EE(WRD), Namsai Division and the appellant Shri Mamu Sono found absent, however, the appellant has submitted an application addressed to the Commission requesting to dispose off the appeal case No. APIC-286/2024. The appellant has also stated that all the information sought by him has already been provided by the PIO and he is satisfied with the information provided.

Request accepted and the appeal case No. APIC-286/2024 is disposed off and closed once for all.
