- (l) Furnish if any MLA Note Sheet copies.
- (m) Furnish price bid copies & Technical bid copies.
- (n} Furnish who Work executed DDSE/EE/AE/JE/if any name List copies.
- (o) Furnish Bank solvencies certificate & GST Certificate return file copies.
- (p) Furnish contractor firms Registration certificate copies & work express certificate copies.

Order of the sixth hearing: *"The commission has directed the PIO to send the information by registered post with AD to the address of the appellant within 1 week from the issue of this order and receipt to this effect be produced during next hearing."*

**Appellant** : Absent.  
**Respondent PIO** : Absent. Shri Takar Gollo, CRCC-cum-DA, represented the PIO. He states that the information has been sent through Registered Postal service on 27.12.2023 in compliance to the Commission's order dated 22.12.1023 and he has produced a receipt copy of it.

### **Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing and perusal of the records, observes that the PIO has complied with the commission's order dated 22.12.2023 by sending the information through registered post within prescribed time period to the appellant. The appellant is absent for four

times hearing consecutively on 01.09.2023, 03.11.2023, 22.12.2023 and 03.02.2025. It appears that the appellant has received satisfactory information from the PIO or he is no more interested to pursue this appeal case.
