**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Denny Lamgu on 24/05/2024 filed an RTI application under Form-'A' before the PIO-Cum-DFO, Bomdila, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 18/06/2024 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 15/07/2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 215/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 times i.e on **29/08/2024, 03/10/2024, 21/11/2024 and 30/01/2024**. The 4<sup>th</sup> hearing held on **30<sup>th</sup> January, 2025** related to the **APIC-No-215/2024**. The Appellant and the PIO found absent during the hearing, without intimating to the Commission for their inability to attend the hearing..

**The Commission observed:**

The Appellant absent for 2(Two) consecutive times despite of issuing summon notice, i.e on 21.11.2024 & 30.01.2025, which makes the Commission believe that the Appellant is not serious on his Appeal, even after warning to the Appellant of his absence of hearing will be decided ex-parte.

Therefore, the Commission here to decide this Appeal ex-parte or disposed.

In view of the above facts and circumstance the Commission finds this Appeal fit to be disposed and closed. And, accordingly, this Appeal stands disposed and closed once for all.
