JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Khunkam Pansa on **01.05.2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (UD & Housing), Longding, District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05.06.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12.07.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 631/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5 (five) time i.e on 09/10/2023, 29/11/2023, 22/01/2024, 10/04/2024 and 12/06/2024. In this hearing of the appeal on 12^{th} day of June, 2024, appellant present and PIO found absent however, the PIO detailed his representative namely Shri Joram Tommy, Accountant and stated that due to undergoing self-medical treatment he is unable to attend the hearing.

During the hearing, representative of the PIO has stated that all the information as sought by the appellant has already been provided to him. Accordingly the appellant agreed with the statement of the PIO's representative and he has satisfied with the information.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
