ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram & Takam Sakap on **31.10.2022** filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of (PHE & WS) Seppa Division, under West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05/12/2022** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **10/01.2023** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 68/2023 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on **05/11/2024, & 17/12/2024**. In this hearing of the appeal on **17th day of December 2024**. The Appellant Shri Riya Taram was not present during the hearing however a representative namely Tamchi Gungte was present and the PIO present during the hearing through online mode.

The Appellant Shri Riya Taram has submitted a letter to the Commission on **17/12.2024** that they have received all the information(s) as sought in their Form 'A' application and have requested the Commission for disposal/closure of their appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances, the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
