## ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram & Takam Sakap on 31.10.2022 filed an RTI application under Form-'A' before the PIO-Cum- EE, Department of (PHE & WS) Seppa Division, under West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant Shri Riva Taram has submitted a letter to the Commission on 17/12/.2024 that they have received all the information(s) as sought in their Form 'A' application and have requested the Commission for disposal/closure of their appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances, the Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
