

**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on **07/03/2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PHED & WS), Lemmi Division, Pakke Kessang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **07/04/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **26/05/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 522/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 11 (eleven) times i.e on 03/07/2023, 28/08/2023, 04/10/2023, 13/11/2023, 29/11/2023, 08/01/2024, 02/02/2024, 06/05/2023, 19/06/2024, 12/08/2024 and 09/09/2024. In this hearing of the appeal on 9<sup>th</sup> day of September, 2024, both the parties, the PIO-cum-Executive Engineer (PHE & WS), Lemmi and appellant Shri Tamchi gungte present.

The PIO has intimated before the Commission that all the information sought by the appellant has already been furnished to him as per his Form 'A' application submitted. It is seen that the case has been pending since 2023, this is the 11<sup>th</sup> hearing. So, the Commission deemed fit to dispose off the case in the presence of both the parties. Accordingly, the appeal case No. APIC-522/2023 is disposed off and closed once for all.
