An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC-354 /2024.

APPELLANT : Shri Chow Lajamang Mannow Village : Nanam Khamti, PO – Manmow,
Dist – Namsai, Arunachal Pradesh.

RESPONDENT : The PIO, o/o the Superintending Engineer (PWD), Tezu Circle, Tezu,
Dist. Lohit (A.P).

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Chow Lajamang Mannow for non-furnishing of below mentioned information by the PIO o/o the Superintending Engineer, PWD, Tezu, Dist. : Lohit, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12-09-2024 :

- (a) Category of work charge (W/C) Serving under the circle;
 - (b) Appointment letter of all the W/C staff serving under the circle;
 - (c) Place of posting of all the W/C staff serving under the circle;
 - (d) Approval from the competent Authority CE or SE, Advertisement details;
 - (e) Interview of Viva details along with board formed then details of the W/C staff recruited under the circle;
 - (f) Present strength of W/C staff under the circle;
 - (g) New Strength or against retirement or vacate of W/C staff under the circle;
 - (h) Total Sanction Strength of W/C staff serving under the circle;
- Period for which information is required : 2020 – till date;

Records reveal that the appellant, Shri Lajamang Mannow had requested the PIO, o/o the Superintending Engineer(PWD) Tezu Circle, Tezu for abovementioned information but the PIO did not furnish the information which prompted him to file appeal before the First Appellate Authority, the CE (PWD), Eastern Zone, Namsai under section 19(1) of the RTI Act vide his Memo of Appeal dt. 24.10.2024. Records further reveal that in response to the said appeal, the FAA, vide letter dt.01.11.2024, intimated the appellant that his appeal can not be entertained by him on the grounds that the on personal enquiry by him, it was found that the PIO concerned had already furnished the sought for information to the appellant.

It is seen that the appellant has, however, filed his second appeal before this Commission vide Appeal Memo dt.05.11.2024 on the ground that the PIO had furnished incomplete information to him and accordingly this appeal was listed for hearing today on 05.02.2025 wherein the appellant was present in person and the PIO, S.S Singh, E.E attended the hearing through VC.

Heard the parties.

The appellant, while admitting that he has received some of the information, reiterated his demand for the remaining information relating to the appointment order in respect of 2(two) employees. The PIO responded by saying that the remaining information is ready for furnishing to the appellant.

Upon hearing the parties and the copy of application dt.12.09.2024, this Commission directs the PIO to furnish the remaining information i.e the copies of appoint order in respect of 2(two) employees as demanded by the appellant within a period of one week from today.

This appeal is, accordingly, disposed of and closed in above terms.
