JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Dorjee on 25/4/2023 filed an RTI application under Form-'A' before the PIO-cum Executive Engineer (PHE) Dirang Division. Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **24/01/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **4/03/2024** and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 142/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for five times i.e on **09/05/2024, 20/06/2024, 13/08/2024, 14/11/2024 & 21/01/2025.**

In this hearing of the appeal on **21st day of January, 2025.** The PIO and Appellant both are present during the hearing through online mode.

However, the Appellant has informed the Commission during the hearing, that he has received all the information as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information sought from the PIO.

In view of the above, facts and circumstance, this Commission find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed.
