**Information sought :**

The appellant file an RTI Application dated 14/08/2024 seeking Details Construction of 132 KV line from Naharlagun to Sagalee under the comprehensive scheme for strengthening of transmission and distribution in Arunachal Pradesh.

The PIO furnished the relevant information which available in their record to the appellant on 05/09/2024.

Being dissatisfied, the appellant filed First Appeal dated 20/09/2024. No hearing has been conduct by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tana Marting on **14.08.2023** filed an RTI application under Form-'A' before the PIO-Cum-DLRSO, Yupia, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **20.09.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **10.10.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1060/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on **01/07/2024 and 16/09/2024**. In this hearing of the appeal on 16<sup>th</sup> day of September, 2024, both the parties present and PIO has intimated to the Commission on that the RTI filed by the appellant was construction of 132 KV line from Naharlagun to Sagalee under Comprehensive Scheme for strengthening of transmission and Distribution in Arunachal Pradesh. The PIO also stated that no such scheme project was sanctioned during the filing of his RTI application. Accordingly, it was only under process and PIO stated that even then they are furnished information to the appellant which are available in their record.

The Commission deems that the appellant has filed immature RTI Application before the PIO. The appellant is also advised to file RTI application in the office of the PIO-cum-DLRSO, Yupia in the appropriate time after sanction of Scheme/Projects.

Therefore, Commission deemed fit to dispose off the appeal case No. APIC-060/2023 filed against the PIO-cum-DLRSO, Yupia. Accordingly, the appeal case is disposed off and closed once for all.


