First Appellate Authority's Order : Videletter dated 06.11.2023, FAA cum SE (E) Naharlagun has directed the EE cum PIO (E) Electrical Division Itanagar to furnish the sought information to the appellant.

Second Appeal filed : on 19.12.2023

**Information sought:**

The appellant filed RTI application dated 19.09.2023 seeking following information regarding Expenditure and implementation of under Smart Street Lights Project scheme/ sanction order/ complete work.

- I. Furnished the true copy fund approved and sanctioned amount, under Smart Street lights Hollongi to Itanagar.
- II. Furnish true certified copies of the all-technical sanction including the technical estimate and design and total number of street lights pole Hollongi to itanagar.
- III. Furnish true certified copies of work completed photo copy with GIO-TAGG copy etc.
- IV. Furnish true copies of DPR copy and NIT copy, NIT participate of firm list of copy.
- V. Furnish true copy site infection report copies with work progress report copy.
- VI. Furnish true certified copy Bill Challan copy with Cash Memo copy.
- VII. Furnish true copy of social audit report, if already conducted.
- VIII. Furnish true certified copy of transaction details through statement ex- chequer etc.
- IX. Furnish true copy of the proprietor's name copy with GST copy and Return fill copy.
- X. Furnish true copy of Advertisement and Newspaper copy.
- XI. Furnish true copy of contactor and Department agreement copy.
- XII. Furnish true copy of money receipt copy with cheque receipt copy.

Period for which the information asked for 2021-2022.

#### **Previous hearings:**

First hearing :26.09.2024, PIO present & appellant present.

In first hearing : *"The commission has directed the PIO to furnish information to the appellant within 3 weeks from the date of receipt of this order under intimation to this commission. Further, the commission has also directed the appellant to serve a copy of this order to PIO, obtain acknowledgement and submit a copy of it to this commission".*

#### **Relevant facts emerging during hearing:**

The following were present:

Appellant : Present. He states that PIO has not yet furnished information to him.

Respondent PIO : Present. He states that the named scheme in RTI application: "Smart Street light Hollongi to Itanagar" is not implemented under his division – Capital Electrical Division, Itanagar. This was duly intimated to the applicant on 05.10.2023 and on 21.10.2024.

On interjection the appellant states that he has not received such intimation from the PIO.

PIO- the Executive Engineer, Capital Electrical Division, Itanagar has produced a copy each of the letter dated 5.10.2023 and 21.10.2024 during hearing.

**Decision:**

The commission after adverting to the facts and circumstance of the case, hearing the parties and perusal of the records, observes that the PIO has already replied the RTI query to the applicant. A copy each of reply letters dated 05.10.2023 and 21.10.2024 to the appellant by the PIO produced in the court during hearing today was seen by the appellant, is enclosed herewith. The appellant agreed to close this appeal case and dispose of.
