
As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 04/09/2023. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa & Smti Yukar Yaga on **01/07/2023** filed an RTI application under Form-'A' before the PIO-Cum-District Medical Officer, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **03/08/2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **04/09/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 979/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on **23/09/2024 and 30/10/2024**. In this hearing of the appeal on 30th day of October, 2024, PIO is represented by Dr. Boni Tuluk, DPO, NBDP, Kamle District but appellant found absent without any information to the Commission. The PIO had brought the documents sought by the appellant on last hearing dated 23/09/2024 and was ready to hand over the same, but due to absence of the appellant document could not be handed over. Today on 2nd hearing date 30/10/2024 also the PIO has brought all the documents before the Commission to be provided to the appellant but they are found absent. The appellant was given last chance to appear before the Commission and directed to collect the information from the PIO's office. The appellant has been absent consecutively 2 (two) times inspite of giving notice and sharing the cause list through whatsapp group in which their names are included.

Therefore, the Commission deems that the appellants are not interested to pursue the appeal case further. The appeal case No. APIC-860/2023 is disposed off and closed once for all. However, the appellant is liberty to appeal before the appropriate higher court if he feels aggrieved by the decision of this Commission.
