JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Riya Taram, Shri Tab Sajang and Shri Jumbey Tsering on 03.08.2022 filed an RTI application in Form-A to PIO cum Executive Engineer PHE & WS Division Bomdila, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal on 12.09.2022 before the First Appellate Authority, the Superintending Engineer, PHE & WS Deptt., Rupa Circle, Rupa.

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 20.10.2022.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.703/2022 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 10.06.2024. Notice of hearing dated 12.04.2024 were served to PIO and the Appellant.

In this final hearing of the appeal on 10.06.2024 the respondent PIO is absent. The appellant Shri Riya Taram appeared.

Heard the parties present.

The appellant submits in writing that he has received all the information sought in RTI application in form-A and requested the commission to drop / dispose of this appeal case on the ground of satisfactory receipt of all information from the PIO.

In view of above facts and circumstances I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.
