**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellants Shri Nabam Tai on **19/02/2024** filed an RTI application in Form- 'A' before the PIO-cum-Divisional Forest Officer (DFO), Tawang Forest Division, Tawang District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' applicant. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on 23/03/2024. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on 01/05/2024 and the Registry of the Commission (APIC) having receipt of the complaint registered it as **APIC No-192/2024 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearings before the Commission, for 3 (three) consecutive hearings on 18/06/2024, 30.07.2024 and 26.11.2024. In the final hearing of the appeal the Appellant Shri Nabam Tai, present in person. The PIO is also present through online mode.

Heard the Appellant and the PIO:

The PIO stated that all the information(s) sought by the Appellant are already furnished to the Appellant. The Appellant informed the Commission that he has satisfactorily received all information(s) from the PIO, and requested the Commission of disposal of this appeal on the ground of satisfactorily receipt of all information(s).

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed of and closed once for all.
