Information sought :

The appellant file a RTI Application dated 19/09/2023 seeking Details regarding the artificial plantation and Avenue trees plantation of entire Kurung Kumey District under the CAMPA Scheme since 2012-2022.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 25/10/2023. First Appellate Authority has conducted hearing on 17/11/2023. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tadar Chai **19.09.2023** filed an RTI application under Form-'A' before the PIO-cum-Divisional Forest Officer, Koloriang Forest Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **25.10.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information commission on **06.12.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1156/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for seven times i.e on 14/08/2024, 16/09/2024, 28/10/2024,18/11/2024,09/12/2024,03/02/2025 and 17/03/2025. In this hearing of the appeal on 17th day of March, 2025, both the parties, PIO-cum-Divisional Forest Officer, Koloriang Forest Division and Appellant Shri Tada Chai present. The PIO has brought all the information as sought by the appellant and handed over to the appellant and the appellant received the information stated that he is satisfied with the information.

Accordingly, the appeal case No. APIC-1156/202s is disposed off and closed.
