ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Smti Yukar Yaga, c/o Jullang near Sonam Nursery, Po/Ps-Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/06/2023 regarding Expenditure and implementation of SADA/SID/RE/ADA/RIDF of entire Kamle District.

The 4th hearing is held today on 11th June' 2024 (Tuesday) at 1030 hrs. Er. Jilek Hiri, the PIO-Cum-EE(RWD), Govt. of A.P., Raga Division, Kamle District, Arunachal Pradesh and the Appellant Shri Palen Laa are absent. Since, both are absent the commission could not hear from them.

Regarding "Show Cause Notice" served to the PIO. In his reply the PIO has wrote a letter to the Commission vide No. RWD/Kamle/Misc-01/2020-21 Dated Raga, the 10th June' 2024 that he was busy with simultaneous election duty of India, he could not attend the court hearing.

The Appellant has made a correspondence to the Commission vide letter No. Nil Dated 07/05/2024 that as per the directions of the Commission to the PIO, the PIO has furnished all the information on 14th April' 2024. After going through the information in detail, the Appellant has found satisfaction and requested the Commission to disposed of the case.

Hence, the case is disposed of and closed.
