## **JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Nabam Tai on 12/8/2024, filed an RTI application under Form-'A' before the PIO-Cum- DFO Van Vihar Chimpu Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 22/10/2024, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 13/12/2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No 437//2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on dated 13/12/2024 & 12/8/2025.

Details of information sought by the Appellants.

- (i) Forest Research Rs 30 lakhs,
  - (a) Copy of the research work done
- (b) Name of Scientist and subject wise research done by them with copy of uc, pr report, research publication etc.
- (ii) O/C Human Resource Development Rs. 20 lakhs
  - (a) Total number of Human/person trained and areas of activities done.
  - (b) UC, Progress report and photograph of the person trained and name and addr participant,
- (iii) O/C Recreation/Beautification of Forestry Rs. 20 lakhs
  - (a) Name of activities carried under this scheme.
  - (b) UC and photograph of the work done with location.
- (iv) OC SFRI Publication Book Rs. 50 lakhs
  - (a) Furnished copy of the publication of the book
  - (b) Name of firm who published the SFRI Book
  - (c) Copy of NIT/ Publication order.

## The Commission observes that;

In the final hearing today on 12<sup>th</sup> day of August 2025, the Appellant and the PIO both found absent during the hearing. It is to be noted that in the 1<sup>st</sup> hearing held on 13/3/2025 the representative of the PIO stated before the Commission that the PIO has given all the information(s) to the Appellant and receipt of the information(s) also has been obtained from the Appellant on 3/2/2025.

The Appellant absent consecutively for the 2<sup>nd</sup> time as he was also absent in the 1<sup>st</sup> hearing held on 13/3/2025, though summon to the Appellant to be present on the next date of hearing that is today had been sent to the Appellant on 13/3/2025 with warning that, in his failure to attend the next hearing, this appeal will be heard and determined ex-parte.

After going through the statement of the representative of the PIO in the last hearing held on 13/3/2025 it is accepted by the Commission that the information has been provided to the Appellant and that is the reason why the Appellant has not turned up for the 1<sup>st</sup> hearing as well as today also, in the 2<sup>nd</sup> hearing.

While the Appellant was sent notice for the first hearing of 13/3/2025, on 23/12/2024 and notice for the 2<sup>nd</sup> hearing was ordered on 13/3/2025 for today. Despite repeated notice sent to the Appellant the absence of the Appellant to attend the hearings amply proves that he is not serious in his appeal and he has received the information(s) on 3/2/2025 relying on the statement of the representative of the PIO, on 13/3/2025. Under the above circumstance the Commission hereby deems it fit to dismiss this Appeal forthwith.

In view of the above facts and circumstances the Commission, find this appeal fit to be dismissed and closed. And, accordingly, this appeal stands dismissed and closed once for all.
