## An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-447/2024.

## <u>ORDER</u>

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Lajamang Mannow for non-furnishing of below mentioned information by the PIO o/o the Executive Engineer (WRD) Deomali Division, Dist : Tirap, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.08.2024.

A) Particular of information : C/o Taphu MIC at Hakum Village in Tirap Dist. B)Details of information :

- Certified copy of detailed project Report and sanctioned Memo alongwith First & Final bill of the said scheme ;
- 2) Certified copy of the measurement book of the said scheme;
- 3) Certified copy of the Notice Inviting Tender of the said scheme ;
- 4) Certified copy of name of Firms alongwith submitted documents;
- 5) Certified copy of name of Firm who qualified in the technical bid and participated in the technical bid alongwith comparative statement ;
- 6) Certified copy of agreement between Executive Engineer and the Firm owner;
- Certified copy of details of payment done through cheque / PFMS mentioned in the First & final bill;
- 8) Certified copy of Board Members of the Tender processing;
- 9) Certified copy of Geo-tag of the said scheme, before starting and after completion of the said work;
- 10) Certified copy of Design & drawing of the scheme and
- 11) Certified copy of Utilization Certificate & Completion Certificate of the scheme.

This appeal was listed for hearing today on 04.04.2025 wherein the appellant, Shri Chow Lajamang Mannow was present in person but the PIO, o/o the E.E(WRD), Deomali Division was absent.

Records in the appeal reveal that in response to the RTI application of the appellant, the PIO, vide letter dt.13.09.2024 had furnished the sought for information

to the appellant after the payment of Rs.170.00 by the appellant against the cost of documents. However, the appellant was not satisfied with the information so furnished by the PIO and therefore, he approached the 1<sup>st</sup> Appellate Authority, the CE(WRD), Eastern Zone, Miao vide his Memo of Appeal dt.04.10.2024 on the ground that the PIO did not furnish the complete information as sought for by him.

The FAA, it reveals, had conducted the hearing on 12.11.2024 and disposed of the appeal with the following direction to the PIO:

"Both the PIO and Appellant were given equal and fair opportunities in the interest of natural justice upon hearing the PIO cum E.E and on scrutiny of information furnished by the PIO, Deomali by relying on the letter vide no. DWRD/AB-46/2019-20/458-59 dated 13<sup>th</sup> sept'2024, the PIO is directed to furnished the name of firms participate in the tender process and copy of measurement book in certified true copy within 20 days from the date of issue of this order."

In compliance with the order of the FAA dt. 12.11.2024, the PIO furnished the remaining information namely the copy of Tender opening Certificate along with the names of participating firms and the CTC of Measurement Book.

During the course of hearing today, the appellant has acknowledged the receipt of the above left out documents and also expressed his satisfaction therewith.

In the premises as above, this appeal does not require any further hearing and consideration by the Commission and resultantly it stands disposed of and closed.
