This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Riya Taram on **18.08.2023** filed an RTI application in Form-'A' before the PIO-Cum-EE, Department of Power, Roing Division, Dibang Valley District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **19.09.2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.02.2024** and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 123/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twice i.e on 30.04.2024 & 16.05.2024. In the hearing of the appeal on 16th day of May,2024. The Appellant Shri Riya Taram and the PIO were absent during the hearing.

After going through the available documents and order passed by the Commission in the last hearing i.e. on 30.04.2024, the Commission observed that the Appellant is directed to collect the information from the PIO's office immediately, after depositing the requisite fee but the Appellant failed to appear before the Commission nor he has intimated the reason for his inability to attend the hearing. Moreover, he was already intimated the date for today's hearing.

On the above facts & circumstances, the Commission opines that the Appellant has collected/received the information from the PIO and he is fully satisfied with the information received from the PIO. Hence, the Commission find this appeal fit to be disposed off and closed.

And, accordingly, this appeal stands disposed off and closed once for all.
