**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Yumpe Nada & Ms. Bengia Mama on **12.09.2023** filed an RTI application under Form-'A' before the PIO-Cum-District Animal Husbandry & Veterinary Officer, Likabali, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13.10.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21.11.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1065/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on **29/05/2024, 24/06/2024 and 21/08/2024**. In this hearing of the appeal on 21<sup>st</sup> day of August, 2024, PIO present and appellant found absent without any information to the Commission.

As per the second hearing on 24/06/2024, the information sought by the appellant has already been provided and the appellant was given time to go through and was asked to intimate to the Commission before the next date of hearing. The appellant has got more than 1 (one) month time to go through the documents/information and was supposed to intimate regarding his satisfaction or dissatisfaction. Information regarding next date of hearing was already intimated to the appellant on the second hearing i.e. on 24/06/2024.

The Commission deemed fit to be disposed off the case assuming that the appellant has no any objection regarding the information provided to him. And, accordingly, this appeal stands disposed off and closed once for all.
