JUDGMENT/ORDER

This is an appeal file under sub-section (3) of section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Palen Laa and Smt Yukar Yaga on 20/06/2023 filed an RTI application under Form 'A' before the PIO-Cum-Executive Engineer, (PHE & WS), Raga Division, Kamle District, Govt of Arunachal Pradesh whereby seeking various information, as quoted in Form-A application. The appellant having not received any documents from the FFA filed an appeal before the Commission.

Accordingly, matter come up for hearing before the Commission i.e on 13/11/2023, 08/01/2024, 02/02/2024, 08/05/2024 and 24/06/2024

The appellant was consecutively absent during the hearings on 02//02/2024, 08/05/2024, and 24/06/2024 in spite of giving last warning summon notice.

The appellant has been given sufficient time to appear before the Commission and it was clearly stated that if appellant is absent without any notice or information, the case will be decided in his absence.

In view of the above fact and circumstances, the commission deemed fit to dispose and closed the case in absence of appellant. An accordingly, this appeal case APIC No. 817/2023, stands disposed off and closed once for all without any further notice.
