**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Teli Naga, C/o LL. Consultancy RTI & Legal Matter, Niya Namchang, Banderdewa, Po/Ps-Banderdewa, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DFO, Bomdila, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 04/07/2023 regarding **Alternative land use programme, Treatment of pilot areas, Salary/wages for engaged supervisors, training and project implementation management.**

**The 2<sup>nd</sup> re-scheduled hearing was held on 3<sup>rd</sup> December, 2024 (Tuesday) at 1030 hrs.** Shri Chuku Loma, the PIO-cum-DFO, Bomdila, West Kameng District, Arunachal Pradesh was absent. The Appellant, Adv. Teli Naga was present on hybrid mode. The Appellant said that he had submitted a letter to the Commission Vide Letter No. Nil Dated 11<sup>th</sup> November 2024 stating that all the required information had been furnished by the PIO-Cum- DFO, Bomdila, West Kameng District on 17<sup>th</sup> October' 2024 through the Postal services. On receiving the documents the Appellant expressed his satisfaction over the information and prayed Commission to dispose off the case.
