ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Phassang Pada & Party on 02.06.2023 filed an RTI application in Form-A to the PIO-Cum-EE, PWD Sangram Division, Kurung Kumey District A.P., whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority Cum SE PWD, Yachuli Circle, Govt. of A.P. on 11.07.2023.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 24.07.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.666/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 26.08.2024. Notice of hearing dated 03.07.2024 were served to PIO and the Appellant.

In this 3rd hearing of the appeal on 26.08.2024 the respondents PIO Cum EE, PWD Sangram Division, Kurung Kumey District A.P. is absent. The appellant Shri Phassang Pada and Tadar Tasuk both appeared.

Heard the appellants.

The appellants submits that they have received the information documents. They further state that the single scheme for which information sought falls under three distinct places and they are unable to make out items of work falling to these three places from the copy of DPR provided to them.

On perusal of this appeal case file record, it is seen that the appellants were directed in the 2<sup>nd</sup> hearing order dated 19.1.2024 to file written submission to the PIO stating any shortfall / incorrect information if any. So far, they have not filed any such written submission.

After hearing the appellants and perusal of appeal case file records the appellants are again directed to submit a written submission to the PIO stating clearly about incomplete information /clarification without deviation from the content in the original RTI application in Form 'A' within seven days from the date of receipt of this order.

The appellant shall serve a copy of this order to PIO along with his written submission if any and obtain acknowledgement receipt from PIO/office. Submit a copy of acknowledgement receipt obtained from PIO /office or a report of correctness of the information to commission within a period of three weeks from the date of receipt of this order for further hearing / closure of this appeal case.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report from PIO and appellant.
