**Order**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Ngenseng Enling on **02.02.2024** filed an RTI application under Form-'A' before the PIO-Cum-DFO, Namsai, Namsai District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **22.03.2024** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **25.07.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 214/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for Once i.e on 29.08.2024 In this hearing of the appeal on 29<sup>th</sup> day of August, 2024. The Appellant Shri Ngenseng Enling and the APIO heard through online mode.

Heard both the parties.

The Appellant stated before the Commission that he has not received full information(s) as applied in his application.

The APIO stated before the Commission that the PIO has already furnished the available information(s) to the Appellant and as per the order of FAA the Appellant is directed to collect the left out information(s) from the office of the DRDA, Tezu because Namsai was a part of Tezu in the year 2016.

After hearing the APIO, the Commission ordered:

- (i) The Appellant to collect the left out information(s) from the office of the DRDA, Tezu or else if he needs he is given liberty to file a fresh application seeking information(s) prior to 2016 information(s), which are not available in Namsai.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed, as the PIO has furnished the information(s) as available in his office to the Appellant And, accordingly, the Appellant also admitted and agreed with the APIO, and hence, this appeal stands disposed and closed once for all.
