Information sought :

The appellant file an RTI Application dated 13/08/2024 seeking Details regarding appointment of official and supporting staff in the office of the SPD, Department of Education.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 23/09/2024. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Taba Pol resent in person

Respondent : PIO-cum-Dy, State Project Director, ISSE, SSA present in person.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Taba Pol on **13.08.2024** filed an RTI application under Form-'A' before the PIO-Cum-State Project Director, ISSE, SSA, Deptt. of Education, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A

application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23.09.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **27.11.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 375/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 21/05/2025. In this hearing of the appeal on 21st day of May, 2025, both the parties the PIO-cum- State Project Director, SAMAGRA SHIKSHA, Deptt. of Education and the appellant Shri Taba Pol present in person.

The appellant has made submission before the Commission today that the information sought in Sl. No. 1 and 2 has been provided.

Query No. 7 is been provided partly. As per the submission made by the PIO Joining letter will be provided which are available in the office and advertisement copy is not available so cannot be provided. As per the statement of the PIO there is no RR for attachment of the Teacher from Elementary Education to SAMAGRA SHIKSHA/ISSE under State Project Director. There is no RR for Group C & D staff as sought in query No. 7. Group C & D staff are purely contractual and contingency staff. Whatever information is available to be provided is the joining letter of Group C & D staff at query No. 7 will be provided but query No. 4 and 5 are hypothetical question which is not liable to be answered by the PIO.

The information sought by the appellant is complete and deems fit to dispose the case in presence of both the parties. Therefore, appeal case No. APIC-375/2024 is disposed off and closed.
