ORDER

Facts:

The brief facts of the case, as reveals from the records, are that the appellant, Shri Mamu Sono, vide his application dt.20.03.2023 filed before the Public Information Officer o/o the E.E (WRD) Bomdila Division West Kameng District, Bomdila, has sought information Scheme List under SADA, ADA, SIDF and IRDF for the period from 2010 to till date (20.03.2023)

Having failed to obtain the sought for information from the PIO nor any positive response from the First Appellate Authority, the Chief Engineer, WRD Western Zone, Itanagar, the appellant preferred this second appeal before the Commission vide his Memo dt.23.05.2023.

Hearing and decision:

The appeal was heard for five times on 21.12.2023, 21.01.2024, 20.03.2024, 22.05.2024 and 19.06.2024.

In all the previous 4 hearings either the PIO or the appellant was absent but the Commission consistently kept issuing direction to the PIO to furnish the sought for information and the appellant to collect the information from the office of the PIO, Bomdila.

In the 5th hearing on 19.06.2024, however, both the appellant and the APIO, Er. Shri Debia Kojum, ASW o/o the E.E (WRD) Bomdila Division West Kameng District, Bomdila, were present and during the course of hearings the APIO handed over the sought for information to the appellant who received the same and expressed his satisfaction thereof. Thus, both the parties pleaded for closure of the appeal.

Under the premises as above, the Commission is of the view that no further adjudication on the appeal is warranted and accordingly this appeal stands disposed and closed.
