SUMMON

WHEREAS, in connection with the APIC-No. 34/2025, your personal appearance is required before the Commission on 29th July, 2025 at 02:30 PM. The 1st hearing held on 1st May 2025. The Appellant Shri Mamu Sono, found absent during the hearing and PIO-cum-EE, Power/Electrical, Bomdila Div. W/Kameng, is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission hereby orders;

- (i) To <u>summon</u> the PIO to appear in person or through online mode before the Commission in the next date o hearing. Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.
- (ii) To **summon** the Appellant to appear in person or through online mode before the Commission in the next date of hearing. Failing which his appeal shall be decided ex-parte.

Due to absence of the both the parties, the Commission could not proceed the hearing of the appeal today.

The next date of hearing be fixed on 29th July 2025 at 2:30 PM (Afternoon).
